
This agreement by both the party shall be for a period of three years from the date of commencement and shall automatically stand terminated upon expiry unless extended by mutual agreement.

4. All billing for canteen services will be the responsibility of Second party.



The decision of the sole arbitrator shall be the final and binding on both the parties on the provisions of Arbitration and Conciliation Act.1996 and amendments. The agreement shall constructed and interpreted in accordance with the Law of India at the honorable law of court at Bhopal, Madhya Pradesh.




