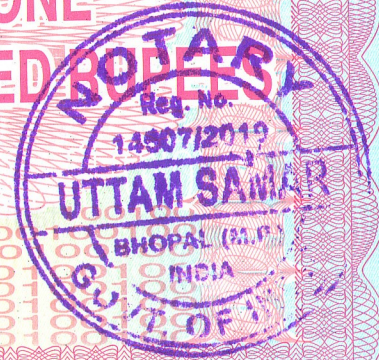
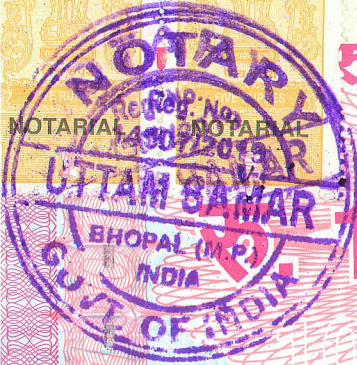

If in the opinion either any of the parties there are reasonable cause or dissatisfaction of service and payment, any of the party may entitle to terminate this agreement by a written 30 days notice to the other party and none shall not 5 have claim for any damage/compensation for the termination of agreement.
5. In case of any disputes/differences arises between the parties in connection with any relating to this agreement including termination therefore, the same shall be referred to arbitration by a sole arbitrator mutually appointed by both parties. The decision of the sole arbitration shall be the final and binding on both the parties on the provisions of arbitration and conciliation Act 1996 and amendmends The agreements shall constructed and interpreted in accordance with the law of India at the honourable Law of court at Madhya Pradesh.
