

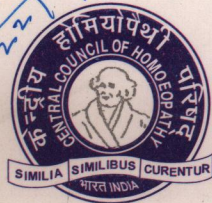

With reference to your letter No.141/A151/BPI dated 20.1.2000 on the subject cited above, I am directed to say that the Executive Committee of this Council in its meeting held on 27.3.2000 discussed the Inspection Report of Narayan Shree Homoeopathic Medical College and Hospital, Bhopal and decided to extend the recognition of the said College for admitting students in I-BHMS Direct Degree Course for the sessions 2000-2001 & 2001-2002 only and also it allowed increase in its intake capacity to 100 students only subject to the condition that the College and attached hospital shall further strengthen the facilities in terms of accommodation, teaching and hospital staff, equipment and clinical training facilities in the Homoeopathic I.P.D. and O.P.D. in the attached hospital to ensure that it meets the student-bed ratio of 1:1 and provide also atleast 10 peripheral homoeopathic OPDs and also make arrangements for having all pre-clinical, para-clinical and clinical departments pertaining to subjects to be taught to the students of B.H.M.S. Degree Course.

Matter concerning extension of further recognition will be decided after receipt of compliance report and a fresh request in the matter.
